

Terms & Conditions ONE THOUSAND DRAWING PENSION PLAN

Hereinafter referred to as “the artist”

Article 1:

The artist sells and contributes ownership of the selected artwork to the buyer.

Article 2:

The selling price of the artwork is set at € 1, - excl. VAT per month upon to 2050.

Article 3:

The delivery of the artwork occurs through postal mail after the payment of € 12,- to bank account number NL58INGB0007107330 in the name of Stichting Plus-X-Creative C X Gottenkieny.

Article 4:

The payment for the artwork proceeds in instalments by automatic bank transfer. The buyer pays € 1.06 monthly to the artist until 2050, or for as long as buyer is alive.

Article 5:

The instalment needs to be paid by the 15th of each month by direct bank transfer to account NL58INGB0007107330 in the name of Stichting Plus-X-Creative C X Gottenkieny. Purchaser proposes an automatic payment by standing order at the bank of the buyer.

Article 6:

When the term of payment is not met, statutory interest and / or any in- and extrajudicial collection costs shall be borne by the buyer.

Article 7:

When the buyer deceases, the payment of the artwork is completed.

Article 8:

The buyer will take care of the artwork as a good father.

Article 9:

The artist gives the following guidelines for proper handling and protection of the artwork: TAKE CARE!

Article 10:

The artist is not liable for damage to the work that occurs due to an incorrect treatment of the artwork.

Article 11:

The artist is available for (advice) restoration and repair work on the basis of a reasonable fee.

Article 12:

The artist is responsible for construction defects and / or hidden defects that occur within one year after delivery of the artwork under the condition that the buyer after discovery of the defect reports it to the artist as soon as possible. In consultation between the artist and the buyer will be sought towards a reasonable solution.

Article 13:

When the damage referred to in Article 12 is not possible to repair, the artist will pay the buyer a fee which does not exceed the original purchase price (including discounts).

Article 14:

1 year after delivery of the artwork voids the liability of the artist.

Article 15:

Even after selling the artwork, the artist retains the entire copyright of the work.

Article 16:

If the buyer wishes to make the work public or wants to reproduce and / or exploit the artwork, the buyer requires the explicit written permission of the artist, who can refuse or attach conditions.

Article 17:

The buyer may reproduce the artwork and / or make photographic images for insurance purposes or for purposes in accordance with the Copyright Act.

Article 18:

Correspondence between the artist and the buyer shall be sent to the last address that the artist and the buyer has made known and vice versa.

This Agreement is governed by Dutch law.

When the artist deceases, the rights of the artist will be inherited by his heirs.
